G. PUBLIC HEARING:

1. General Plan Update – Review and Recommendation to the City Council.

The City of Ione is in the process of comprehensively updating its General Plan. On August 5, 2009, the Planning Commission will be reviewing the draft General Plan policy document and accompanying Draft Environmental Impact Report and draft Final Environmental Impact Report and will consider making a recommendation to the City Council to certify the Environmental Impact Report and adopt the General Plan. The General Plan lays out the framework for all future growth and development within the City. Any actions, projects, and decisions must be consistent with the goals, policies, and land use map contained in the General Plan. The Plan serves as the primary planning and regulatory tool of the City

Staff recommends that the Planning Commission:

1. Receive staff's presentation;
2. Open the public hearing and take public comment;
3. Close the public hearing; and
4. Adopt Resolution 09-4, a Resolution of the Planning Commission of the City of Ione Recommending that the City Council Certify the Environmental Impact Report and Adopt the 2009 General Plan (Attachment 1).

2. Zoning Code Update and Rezoning – Phase 2 Amendments For General Plan Consistency. In conjunction with the pending General Plan Update, the Planning Commission will consider recommending to the City Council adoption of a series of amendments to Title 17 of the City of Ione Municipal Code (the Zoning Code) and concurrent amendments to the Citywide Zoning Map. The proposed amendments build upon the comprehensive Zoning Code update completed in spring 2009 (referred to as Phase 1). The purpose of these proposed amendments (Phase 2) is to implement and provide consistency with the proposed General Plan, if ultimately adopted.

Staff recommends that the Planning Commission:

1. Receive staff's presentation;
2. Open the public hearing and take public comment;
3. Close the public hearing; and
4. Adopt Resolution 09-5, a Resolution of the Planning Commission of the City of Ione Recommending that the City Council Adopt the Proposed Zoning Code Text and Map Amendments for Consistency with the Pending General Plan Update.
