Purpose and Intent

It is the intent of this chapter to establish an abandoned residential property registration program as a mechanism to protect residential neighborhoods within the city limits of the City of lone from becoming blighted through the lack of adequate maintenance and security of abandoned properties.

See City of Ione Municipal Code, Title 8, Health and Safety, Chapter 8.06 "Vacant, Abandoned, Distressed or Foreclosed Properties," section 8.06.010.

Registration

Any beneficiary/trustee who holds a deed of trust on a property located within the City of lone shall perform an inspection of the property that is the security for the deed of trust upon default by the trustor and prior to recording a Notice of Default with the Amador County Recorder's Office. If the property is found to be vacant or shows evidence of vacancy, it is deemed abandoned and the beneficiary/trustee shall, within ten days of the inspection, register the property with the City Clerk's office. See City of Ione Municipal Code, Chapter 8.06, section 8.06.030(A).
