### IONE PARK AND RECREATION COMMISSION MEETING MINUTES February 23, 2021

#### Commissioner Bennett called meeting to order at 6:00 p.m.

#### I. PLEDGE OF ALLEGIANCE:

#### VI. REGULAR ITEMS:

- 1. Usage and Regulations for Tennis and Basketball Courts at Howard Park-discussion items:
  - Finding a different location for basketball courts because of basketball leagues taking over the courts on the weekends--they are putting tape on the courts, which is hard to remove.
  - Groups using the courts for league play should supply insurance to the City.
  - Courts being used by roller skaters.
  - Courts being used for dogs signage needed—no dogs allowed

It was moved by Commissioner Traxler, seconded by Chairman Bennett and carried to send a notice to Mother Lode Miners Basketball League (travel league) and that they contact the City of Ione to discuss their schedule and usage,

Mr. Larry Rhoades talked about allowing the public to use facilities on school grounds, tennis courts, basketball courts, etc.

Ms. Vera Ferguson, Amador Tennis Club stated that they use the tennis courts at Argonaut High School and have never had issues, but they do contribute to the courts by doing Fundraisers.

- 2. Proposed Pickle Ball Courts at Perry Earl Park There was discussion about using the City parcel next to Perry Earl Park for Pickle Ball Courts.
  - Need for restrooms at the Perry Earl Park.
  - Donations for Pickle Ball Courts will be held until we have a facility ready.
  - Two Pickle Ball Courts can fit into one Tennis Court
  - Need estimate of cost for Pickle Ball Courts to make Fundraising easier include option of lights
- 3. Per Capita Grant Depot Park There was discussion on the following:
  - The City has received approval from the State on the Per Capital Grant of \$177,000 with a 20% match by the City.
  - This grant is only for the Park area and not for the depot itself.
  - The design of the Park has been engineered but not reviewed by the Commission.
  - Laurie Lord has received bids on fencing separating the depot from the park.
  - This item will be on the next agenda for the Commission to review the plans.
- 4. Propane Tank at Howard Park There was discussion on the Propane Tank at Howard Park:
  - Against the City ordinance to have an above ground propane tank within the City limits
  - Propane tank was installed at the direction of the former City Manager and used for the recently installed generator with COVID19 funds from the County
  - Natural gas is available at the park as close as Howard Park
  - The Park & Recreation Commission did not review the placement of the tank at Howard Park
- 5. Status of Nexus and Impact Fee Study Ms. Lori McGraw spoke with Shayne Morgan from Taussig & Associates, who was awarded the contract for the Nexus and Impact Fee Study in 2019. He did not know the reason for no communication from the City, but is still interested in moving forward with the Study. Commission asked possibility of Taussig & Associates making a presentation to the Commission at the next meeting.
- 6. Set Date for 2021 Goals Meeting Commission set the date and time for Goals Meeting of March 23, 2021 at 5:00 p.m. before the next regular meeting.
