Ione Police Department CCW License procedure – INITIAL APPLICATION

1. Read, complete, and *sign Sections 1, 3, 4, and 5 only* of the California DOJ Standard Initial and Renewal Application for License to Carry a Concealed Weapon form.
 - Sections 2, 6, 7, and 8 must be completed in the presence of an Ione PD employee.
 - ***Review Section 7 and be prepared to answer these questions orally. Do not write anything in Section 7.***
2. Complete the Ione Police Department CCW Supplemental Questionnaire form.
3. Submit the DOJ Application, Ione PD Questionnaire, and a non-refundable check or money order in the amount of \$113, made payable to the City of Ione. (This fee includes the \$93 application fee charged by DOJ and 20% of the cost of the application fee charged by the City of Ione.)
4. When you submit the above items, you will receive a Livescan form. Complete the Livescan form, make 3 copies, and contact an agency that performs Livescan services for fingerprinting.
 - Go to <https://oag.ca.gov/fingerprints/locations> for a list of agencies that perform Livescan services.
 - You will be responsible for any rolling fees charged by the location performing the Livescan service.
 - After having the Livescan performed, return one of the Livescan form copies to Ione PD.
5. Once your background check results from DOJ are received, you will be contacted by the Ione Police Department to schedule a personal interview. You will be asked to bring your *unloaded* firearm to the Police Department for a full safety inspection.
6. Complete a CCW firearms training course with your firearm, using one of the approved firearms instructors, and submit the Certificate of Completion to Ione PD.
7. If the CCW license is granted, you will be required to sign a Restrictions and Conditions Agreement, provide a signature and thumbprint on the license, and submit a check or money order in the amount of \$80 to the City of Ione (the remaining balance of the application fee charged by the City of Ione).

Ione Police Department CCW License procedure – RENEWAL APPLICATION

1. No later than 30 days prior to the expiration of any valid license to carry a firearm, the licensee may apply for a CCW renewal.
2. Complete steps 1, 2, and 6 above.
3. Submit the following to Ione PD:
 - DOJ Application
 - Ione PD Questionnaire
 - You DO NOT have to have Livescan services performed again.
4. You will be contacted by the Ione Police Department to schedule a personal interview. You will be asked to bring your *unloaded* firearm to the Police Department for a full safety inspection.
5. Complete a CCW firearms training course with your firearm, using one of the approved firearms instructors, and submit the Certificate of Completion to Ione PD.
6. If the CCW license renewal is granted, you will be required to:
 - Sign a Restrictions and Conditions Agreement
 - Provide a signature and thumbprint on the license
 - Submit a check or money order in the amount of \$52, made payable to “California Department of Justice”
 - Submit a check or money order in the amount of \$75, made payable to “City of Ione” (the cost of the renewal application fee charged by the City of Ione).
