SUBJECT: PURCAHSE & PLACEMENT OF “DOG STATIONS”

RECOMMENDED ACTION:

Recommend approval by City Council of the City of Ione to approve the proposed purchase and placement of twenty “Dog Stations” throughout the City and the associated budget allocation.

FISCAL IMPACT:

The overall fiscal impact to the 2023/2024 fiscal year budget is estimated at \$8,000. This amount covers the purchase price of twenty stations at \$245 each, an additional 15% to cover taxes and contingency, with approximately \$2,400 left to cover two staff members, three full working days to install the stations and any supplies that may be needed for install.

BACKGROUND:

A City Ordinance, Ordinance No. 6.04.030, is already in place stating that pet owners shall be responsible for the fecal matter of their pets. The Ordinance states that animals shall not be permitted to deposit upon private property, public streets, or any other public areas without the immediate removal & disposal.

DISCUSSION:

Several members of the community have been complaining about dog poop being left and we hope that the pet owners will be more inclined to remove and dispose of said poop if there are stations easily accessible throughout the City.

ATTACHMENTS:

A. Ordinance No. 6.04.030

6.04.030 Control—Public places.

No owner of any animal, wild or domestic, shall permit or allow said animal to do any of the following things within the City of Lone:

- A. No person owning or having the care, custody, control or possession of any dog shall allow the dog to remain outside of a secured building or dwelling on the premises of the person unless the dog is within a fenced enclosure which is adequate to contain the dog, or unless the dog is securely tethered so as to prevent the dog from leaving the premises. Any dog so tethered shall be secured in a manner as to be unable to cross the property line on such premises. It shall be further restrained not to enter on any sidewalk, street or any such place designated for the public.
- B. The owner of any animal shall not allow any animal to deposit fecal matter upon any private property, public street, or other public place and the immediate area without removing and properly disposing of the fecal matter.

*Note—Any violation of this subsection within any 12-month period shall constitute a civil infraction punishable by a fine in the amount of \$100.00 for the first violation; \$250.00 for the second violation; and \$500.00 for the third and subsequent violations.

- C. Habitually make loud noise for a period of 15 consecutive minutes or longer, or act in such a manner so as to constitute a public nuisance.

*Note—Any violation of this subsection within any 12-month period shall constitute a civil infraction punishable by a fine in the amount of \$100.00 for the first violation; \$250.00 for the second violation; and \$500.00 for the third and subsequent violations.

SUBJECT: ADOPT A PARK PROGRAM RE-INTRODUCTION

RECOMMENDED ACTION:

No recommendations are necessary at this time.

FISCAL IMPACT:

BACKGROUND:

In 2016 the Adopt-A-Park Program was created. An extensive document was produced that outlined the Program from start to finish. It is unknown to current staff why the Program was never implemented. Staff has made a few updates and would like to re-launch the Program under the supervision of Parks & Recreation.

DISCUSSION:

As we move forward with so many wonderful ideas, park maintenance and updates should be one that we focus on as well. Staff would like to re-launch this Program with heavy emphasis on the community and local organizations adopting parks advertised as “up for adoption”. We propose to advertise three to four parks per year for adoption and provide a full scope of work for updates, modifications, etc. to the adoptive party. The adoptive party can adopt the entire project, certain aspects of the project, or, they can simply make a one-time donation. This will allow the City to make the updates we need with the help of donation. We can add a plaque to each park listing the adoptive party or parties.

Any park can be adopted at any time. More than one party can adopt the same park. All parks will be up for adoption. Adoptive parties can also simply adopt the maintenance of a specific park. Everything is outlined in the document.

Staff would like to suggest that the first four parks to be advertised for adoption are the following;

1. Bridge Park (Park n’ Ride and the Bridge)
2. City Pool (pool includes snack bar, and surrounding areas)

3. Heath Knowell (Welcome Sign)
4. Tennis Courts at Howard Park (for pickleball)

City of Lone Adopt A Park Program

What is the City of Lone Adopt A Park?

Adopt A Park is a City-wide community service program that provides for the health, inspiration, and recreational opportunities for the people of Lone. In addition, the program educates the public about creating and preserving clean and safe parks for everyone. The preservation and maintenance of our natural and recreational resources will ensure the opportunity for high quality leisure experiences for generations to come.

Who can adopt a park?

Anyone can adopt a park! The program aims to unite and support all people interested in improving Lone's neighborhood open spaces. Participants can include:

- Individuals
- Neighborhood Associations
- Schools
- Church Groups
- Non-profit Organizations
- Families
- Senior Citizen Groups
- Youth Groups
- Scouts
- Businesses
- Community Groups
- Local Agencies

What can be adopted?

- Flower Bed Planting/Weeding
- Trees and Shrubs Planting/Watering
- Undeveloped Parkland
- Litter
- Paint
- Other Pre-Approved Park Projects
- Playgrounds
- Courts
- Trails
- Weed Control
- Graffiti Removal
- Structures

What are participants responsible for?

- Participants are required to read, understand, and abide by all safety guidelines.
- Participants must abide by all park rules and ordinances.
- Participants must notify the City of Lone staff representative when performing Adopt A Park activities.
- Participants must keep track of the number of hours spent working on a monthly basis and report total hours to the City staff representative. Hours are due by the 5th day of each month. The City documents this information and will tabulate yearly hours, which helps the program in the following ways:
 - Accounts for total donated time to the program for annual reports and grant qualification
 - Confirms the growth or decline in participation
 - Helps the City provide participant awards and recognition.

City of Lone Adopt A Park Program

Participation can include one or more of the following:

- Improvement Sponsorship
- Donation Sponsorship
- Project Sponsorship

How to Get Started:

- Complete the application and mail, email, or fax it City Hall.
- Select or propose an area you are interested in adopting.
- Notify the City at least five days prior to each work date.
- Review and follow safety requirements.

Our Commitment to You:

- We will provide safety vests to be used when needed on a loan basis.
- We will dispose of the trash and/or organic material collected and we will provide trash bags for you to
- We will work with you to design and implement projects.

Safety:

- Safety is of utmost importance to the City of Lone. We encourage you to take responsibility for your actions and use good judgement while you are working on any Adopt A Park project. Please use the safety regulations as a guide when necessary.

Adopt-A-Park Improvement Sponsorship

BASIC REQUIREMENTS FOR IMPROVEMENT SPONSORSHIP:

- Adopting organization leaders must be aged 18 or older and will be required to attend a brief training session sponsored by the City prior to performing work in the adopted areas as well as be present at the onsite meeting at the start of the sponsorship period.
- Cleanup/maintenance will be done by members of the adopting organization. Cleanup/maintenance will be done as agreed upon between the Department and the individuals or organization, for a designated period of time (dates to be set in conjunction with a City representative).
- All work shall be performed during daylight hours.
- Cleanup may be more often if it is determined that the park or facility is in need of additional improvements.
- Adopted parks will be assigned on a first-come, first served basis.
- Adoption by one organization does not preclude adoption of another area of the same park or donation to the same park from another organization.
- Be familiar with and follow all safety requirements.

YOU OR YOUR ORGANIZATION CAN:

- Pick up litter in and around your adopted site at least monthly. This may include picking up paper, cans, glass, (broken glass to be removed at the discretion of the adopting organization's supervisor), or other garbage and placing it in trash receptacles at the park, or pickup can be arranged by the city for larger amounts.
- Clean and paint buildings or other designated facilities as needed. (The City will supply the paint and painting equipment).
- Plant trees, flowers or shrubs, with approval of the Community Services Department, at the adoption site. Graffiti Removal.

WE AGREE TO:

- Provide training that includes maintenance methods and techniques, and safety issues.
- Meet with the adopting organization (or its representatives) at the adopted park site at the start of the sponsoring period to discuss cleanup and maintenance priorities and to provide general guidance.
- Support the efforts of the adopting organization to keep the park clean and well maintained.
- Assist the adopting organization , and provide technical help when requested.
- Work together with the adopting organization for the betterment of the park.
- List monthly reports on City web page, honoring the work completed by your organization.
- Publicly acknowledge your organization on the City web page, flyers, signs, etc.

City of Lone Adopt A Park Program

APPLICATION:

The adopting organization will need to complete and submit an application to the City at least thirty (30) days prior to the adopting organization's first scheduled cleanup. Please note that the Volunteer Waiver Forms should also be submitted with the application. These forms are included in the Appendix section of this handbook.

CANCELLATION:

If the adopting organization is unable to fulfill its clean-up requirements for thirty (30) days after the scheduled clean-up/beautification date, the organizing leader will be contacted by the Adopt-A-Park Program Coordinator. If clean-up is not accomplished sixty (60) days after the scheduled date, the organizing leader will receive a reminder from the Program Coordinator. If clean-up is not done for a total of 75 days after the scheduled date, the Program Coordinator will consider the adoption cancelled.

SAFETY RULES:

We value your safety. Adult group leaders will be required to attend a training session sponsored by the City and will then be responsible for conducting a safety briefing for all participants prior to a cleanup. Participants and/or parents bear individual responsibility for personal safety and appropriate behavior in the park. Each participant must complete the Volunteer Waiver Form (Appendix). Adopting organizations will work without direct City of Lone supervision. One adult supervisor (aged 18 or older) must be present for every five minors over the age of seven years and one adult supervisor must be present for every two children under the age of seven years. Adoptable areas will be selected for safety and appropriateness for the participants. We urge you to remember: The program depends upon the common sense and responsibility of individual participants. For the protection of our participants, the use of power tools such as mowers, tractors or chain saws will not be permitted.

SAFETY REQUIREMENTS:

- Wear comfortable clothes and closed-toed shoes
- Wear gloves
- Remove all bagged trash
- Be aware of traffic and remain alert to your surroundings at all times
- Do not pick up broken glass without adult supervision
- Do not touch anything that may be toxic/hazardous i.e. oil, paint, gasoline, etc.
- Report all suspected toxic/hazardous materials to the City of Lone

SUGGESTED TOOLS:

- Garbage bags
- Leather gloves
- Shovels
- Rakes
- Brooms
- Water for drinking (especially groups with young children)
- Trash “graspers”

Adoption applications are accepted year round. It is recommended that applications be submitted early, as they are approved on a first come, first served basis (Appendix A-1).
