
SIGN PERMIT CONDITIONS

In addition to the Building Permit application, attach each of the following to this application form:

- 1. Three sets of site plans and elevations (scaled drawings) showing each of the following:
 - a. Project address and name, address, and phone number of the establishment
 - b. Site plan showing length of primary building frontage and location of all freestanding signs (including dimensions to the right-of-way lines, property lines, sidewalks, driveways, streets/alleys and other structures existing or approved on the project site.
 - c. Building elevations including the position of all proposed and existing building attached signage showing width and length of dimensions for lettering or image, each cabinet sign, material specifications, and colored renderings. Also identify any clearance dimension from adjacent standing surface to the bottom of the cabinet and the proposed illumination of signs.
 - d. Freestanding sign elevations showing all proposed freestanding signage with dimensions of structure (including height from adjacent grade) and showing width and length dimensions for lettering or image of sign face, material specifications, proposed illumination, and colored renderings.
- 2. Any and all additional plans and information required for the necessary building permit(s), along with a completed Building Permit Application Form.
